The Stewards heard evidence from the following persons:

Simon Green (Entrant of Car #31), James Townsend (Driver Car #24) and Jamie Stanley (Team Manager Fox Motorsport). On-board video footage from Car #31 and Car #24 also viewed

The Stewards decision is:

The Appeal Fails and the Stewards support the decision of the Clerk of Course that an advantage was gained (whether inadvertantly or not) and the penalty applied is appropriate.

Reason(s) for this decision:

The Stewards understand from the evidence presented that the driver of Car #31 did make contact with Car #24 at Turn 3 during lap 1 of the Race. The Stewards believe that the contact between Car #31 and Car #24 at Turn 3 was sufficient to affect the momentum of Car #24 allowing Car #31 to pass on the entry to Turn 4 and therefore an advantage was inadvertantly gained. The decision of the Clerk of Course is correct.
