Following investigations I find that you are guilty of contravening Motorsport UK Safety Car Regulations, namely:

Q., Appendix 3, Article 1.6 - Safety Car Infringement (See below for additional information)

Additional Information / Reasons for Decision:

Car 56 locked up and ran wide at T2 on lap 1, car 9 overtook car 56 and was then overtaken by car 78. Car 78 was unsighted for the safety car light panels. Car 9 was forced wide by the move from car 78 and was overtaken by car 56 when off the track. Car 9 then overtook car 56 believing that it had slowed to allow redress of positions.

All three drivers interviewed along with team managers and video from all three cars reviewed
