Reason(s) for this decision:

THE APPELLANT CONFIRMED THAT THEY ACCEPT THE TECHNICAL NON-CONFORMITY OF THE CAR CONCERNED AND SEEK ONLY TO CHALLENGE THE PENALTY IMPOSED BY THE CLERK OF THE COURSE. THE STEWARDS AGREED ON THAT BASIS TO HEAR THE APPEAL.
