The Stewards decision is:

THE APPEAL SUCCEEDS. THE STEWARDS AGREE THAT THE PENALTY IMPOSED BY THE CLERK OF THE COURSE WAS TOO SEVERE. THE ONE POSITION PENALTY TO THE RACE FINISHING POSITION IS DELETED AND THE SUBSEQUENT ADDITIONAL CHAMPIONSHIP PENALTY IS AMENDED AS DETAILED BELOW.

THE STEWARDS GIVE MR BARRABLE A FORMAL WRITTEN REPRIMAND [2 POINTS] AS TO HIS CONDUCT DURING A SAFETY CAR INTERVENTION IN THE FUTURE. THIS DECISION TRIGGERS AN ADDITIONAL CHAMPIONSHIP PENALTY (CR 4.2.3) OF DEDUCTION OF 50 CHAMPIONSHIP POINTS AND START FROM THE PIT LANE IN THE NEXT RACE IN WHICH HE COMPETES.

Reason(s) for this decision:

THE STEWARDS DETERMINE THAT MR BARRABLE DID OVERTAKE CARS 9 & 68 BETWEEN SURTEES AND McLAREN WHILST THE SAFETY CAR WAS DEPLOYED. HOWEVER, THESE TWO CARS HAD MOVED SIGNIFICANTLY TO THE RIGHT HAND SIDE OF THE TRACK AND WE FEEL THAT IT WAS REASONABLE FOR MR BARRABLE TO CONSIDER THAT THEY WERE INTENDING TO ENTER THE PIT LANE HAVING BEEN INVOLVED IN THE INCIDENT AT PADDOCK HILL THAT CAUSED THE SAFETY CAR TO BE DEPLOYED.

WE FEEL THAT THE OVERTAKING MANEOUVRE DID NOT PUT ANYONE AT RISK AND THERE WAS NO LARGE SPEED DISPARITY. THEREFORE, WE TAKE THIS AS MITIGATION WHEN DETERMINING OUR DECISION AND THE PENALTY TO BE APPLIED.
