Additional Information / Reasons for Decision:
Car 56 crowded car 15 off the circuit at the exit of Druids, both cars made contact and left the circuit
Onboard footage of car $15 \& 56$ viewed
ITV Footage viewed
Both drivers and entrant gave verbal evidence in the hearing

Accordingly, I order that you:

| $\checkmark$ | Additional Championship Penalty: 3 place grid penalty at the next available race |

* If your practice times are dis-allowed above, you may, in accordance with Q12.9.3., start the race from the back of the grid with a mandatory 10 second delay or start from the pitlane on the first racing lap.
