

Following investigations I find that you are guilty of contravening the following Motorsport UK regulation: Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car. Additional Information / Reasons for Decision:					
Car 78 attempted an overtake of car 17 at Maggotts on the 1st lap. Car 78 ran wide and spun when rejoining and made contact with car 17. Both cars retired. Video from cars 78, 17 and 4 reviewed. Both drivers and team managers interviewed. Driving Standards Advisor also attended the hearing

* If your practice times are dis-allowed above, you may, in accordance with Q12.9.4., start the race from the back of the grid with a mandatory 10 second delay or start from the pitlane on the first racing lap.
