Following investigations I find that you are guilty of contravening the following Motorsport UK Regulation:

Q12.21.5 - . It is not permitted to drive any car unnecessarily slowly, erratically or in a manner deemed to be potentially dangerous to other drivers at any time.

Additional Information / Reasons for Decision:

Contact between car 18 & car 30 at turn 1 lap 1.

Car 18 made contact with car 30 with car 30 subsequently running wide and losing race positions.

Both drivers interviewed with the team manager.

Onboard footage viewed from Car 18 & 30 and Car 71 which was behind at the time of the incident.

Car 18 was deemed to carry out a maneuver to be potentially dangerous to other drivers.

This penalty carries a 3 championship and 3 category point deduction.
