Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Car 16 made nose into side contact with Car 44 at Old Hall on Lap 2.
 Car 44 continued Car 16 retired on Lap 6.
 Interview with Team Manager representatives from Graves Motorsport (Karl Graves) and Xentek Motorsport (Chris Richards) as both drivers had left the circuit.
 After reviewing onboard footage it was deemed that Car 16 was responsible for causing a collision.
 This penalty carries a 2 championship and 2 category point deduction.
