Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Car 18 made nose into side contact with Car 71 at Knickerbrook In on Lap 13.
 Car 71 continued Car 18 retired.
 Interview with both drivers and Team Managers.
 Onboard footage reviewed from Car 18 & 71.
 After reviewing onboard footage it was deemed that Car 18 was responsible for causing a collision.
 This penalty carries a 3 championship and a 3 category point deduction.
