The Stewards heard evidence from the following persons:

The Stewards met with Dave Tyson (Team Manager #18) and Mick Sargeant (Team Manager #12) to consider admissibility of an appeal lodged against a penalty imposed on #18. After discussion of the timing of both submission and potential hearing of the appeal, the Appellant indicated that there was no point progressing the matter further.

The Stewards decision is:

The Stewards accept the Appellant's indication above as being a withdrawal of the appeal. Under the circumstances they accept that withdrawal and determine that the appeal fee is to be refunded to the Competitor (i.e. the commitment to make payment to Motorsport UK is negated).

Reason(s) for this decision:

The decision which is the subject of this appeal was notified to the competitor at 16:00hrs. The appeal document passed to the Stewards was received by the Clerk of the Course at 16:36hrs. Although this was some 6 minutes after the appeal time limit, the Competitor showed on his phone that he had emailed this to the Championship Co-ordinator at 16:28 hrs, suggesting the appeal may be admissible.

The Stewards explained that if they determined that the appeal was admissible, it would not be possible to complete a hearing and decision before Race 3 as the pit lane was scheduled to open in 10 minutes and the race start 15 minutes later, the drivers would therefore not be available to give evidence. Also, the Competitor wished to rely on data which would need to be obtained and presented by Cosworth, which would take time to obtain.

As the appeal would need to be scheduled after Race 3, the Competitor indicated that there was no point proceeding further as the impact of the penalty would be on the Race 3 grid formation.
