Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

**Q12.21.4** – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Both Drivers and respective Team Managers interviewed and video footage from both cars reviewed.  
 Contact between car 24 & 59, causing Car 59 to spin  
 I find Car 24 predominantly to blame for the incident.

This penalty also carries a 2 Championship and 2 Category Points Deduction i.a.w. CR4.2.3 (A)
