The Appeal Fails and the Clerk of Course decision is upheld

Reason(s) for this decision:

Appeal lodged at 16.46 hours on 27 July 2024 however the next Porsche Sprint race was due to start within an hour and Karl Graves, Team Manager confirmed to the Stewards at 17.15 hours that his driver was accepting the 5 Grid Place drop but Graves Motorsport still wished to pursue their Appeal and agreed that the hearing would be delayed until Sunday morning at 09.15 hours.

The Stewards heard evidence from both drivers and Team Managers together with viewing on-board footage from both cars. Car #44 attempted a pass on the inside into Turn 1 against Car #50 and contact was made between both cars on the entry to Turn 1 for which the Stewards consider the driver of Car #44 was predominantly responsible and see no reason to overturn the decision of the Clerk of Course.
