Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Car 44 made side to side contact with Car 50 at Turn 1 causing Car 50 to run wide into the gravel trap.

Both cars continued.

Interview with both drivers and team managers. Onboard footage viewed from Car 44 & 50.

This penalty also carries a championship penalty deduction.
