ON-BOARD FOOTAGE FROM CAR NOS. 4 AND 56 WAS VIEWED.

The Stewards decision is:

THE APPEAL SUCCEEDS. THE TIME PENALTY IMPOSED BY THE CLERK OF THE COURSE OF 5 SECONDS IS SET ASIDE AND INSTEAD THE STEWARDS IMPOSE A TIME PENALTY OF 5.25 SECONDS.

Reason(s) for this decision:

THE LENGTH OF A TIME PENALTY FOR A BREACH OF Q.12.21.1 IS NOT DEFINED IN GUIDELINE PENALTIES ISSUED BY MOTORSPORT UK. THE STEWARDS DEEM IT REASONABLE THAT THE PENALTY SHOULD ADJUST THE RESULT OF THE RACE SO THAT CAR 4 FINISHES AHEAD OF CAR 56 IN THE CLASSIFICATION.
