Additional Information / Reasons for Decision:

Car 24 attempted an overtake of car 4 at T3 on the first lap of the first start. Car 24 made contact with car 4 forcing car 4 off the track. Video from car 24 reviewed and both drivers and team managers interviewed. Driving standards advisor and Deputy Clerk also in attendance
