Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Car 33 attempted an overtake of car 8 at T1. Car 33 made contact with the rear right wheel of car 8 causing car 8 to spin in to the gravel trap and retire. Video from both cars viewed. Team Manager and driver of car 8 and team manager of car 33 interviewed. Deputy Clerk and Driving Standards advisor in attendance
