Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

On first start into turn one, car 32 lost slight control under braking and made contact with car 3, which in turn caused multiple further contacts and led to a race stoppage. In car footage from car 12 and 32 reviewed and spoke to driver of 32 who accepted what had happened and explained fully what had previously been seen on the footage. No maliciousness was seen.

Accordingly under Motorsport UK Regulation **G5.3.3**, I order that you:

- Be given a verbal warning [0 points]
- Be given this formal written reprimand (C2.1.1.a) [2 points]
- Be fined the sum of (Max £1,150) (C2.1.1.b) [3 points]
- Be given a place grid penalty effective on your next race (C2.1.1.c) [3 points]
- Be given a drive through penalty (Q12.26.a – g) [0 points]
- Be given a Stop / Go penalty Prescribed time of (Q12.26.a -g) [0 points]
- Converted in to a post race time penalty of (Q12.26.h) [0 points]
- Be penalised by the addition of to your elapsed race time (C2.1.1.c) [3 points]
- Be penalised by the addition of position(s) to your race finishing position (C2.1.1.c) [3 points]
- Be disqualified from practice and your practice times are disallowed* (C2.1.1.d) [4 points]
- Be disqualified from the results of the race (C2.1.1.d) [4 points]
- Be disqualified from the results of the meeting (C2.1.1.d) [6 points]
- Be referred to the Stewards of the Meeting for consideration of further penalties
- Be reported to Motorsport UK as a potential breach of the Respect Code
- Additional Championship Penalty: Champ Reg 4.2.3 - 50points and must start next race from pit lane
- 2 Penalty points are recorded on your licence as a result of above (C2.1.5, C2.1.7)

* If your practice times are dis-allowed above, you may, in accordance with Q12.9.4., start the race from the back of the grid with a mandatory 10 second delay or start from the pitlane on the first racing lap.

You are advised of your right of appeal
