

Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:										
Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car. Additional Information / Reasons for Decision: Hearing held over to Sunday from Saturday's final.										
In the final entering turn 3 car 28 made contact with rear of car 2, causing 2 to spin into gravel. At previous corner car 2 had run wide and rejoined track, but had regained position on road. Other cars were too car 28 right so move could not be made there. Under breaking 28 made the contact. Car 28 stated that car 2 had rejoined dangerously. I did not consider it a dangerous rejoin.
