Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

On approach to the hairpin, car 94 out braked himself and made contact with rear of 85 causing 85 to spin. Reviewed in car footage from 94 and spoke to the driver. The move was from a very long way back and i could see an attempt to avoid the contact. But clearly was an avoidable mistake.

Accordingly under Motorsport UK Regulation G5.3.3, I order that you:

	Be disqualified from practice and your practice times are disallowed* (C2.1.1.d)	[4 points]
