Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Contact between cars 1 and 34. Car 1 accepted he was at faults but that any penalty would be inconsistent. I could see from in car footage that there was no overlap and that contact was sufficient to spin car 34.
