Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Reports of contact between Car 87 & Car 3 at McLeans corner on Lap 1. Car 3 spun and continued, Car 87 continued.
Both drivers interviewed with their team managers. Onboard footage reviewed from Car 87.
Car 87 was found to have caused a collision.
