Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Reports of contact between Car 87 & Car 3 at McLeans corner on Lap 1. Car 3 spun and continued, Car 87 continued.

Both drivers interviewed with their team managers. Onboard footage reviewed from Car 87. Car 87 was found to have caused a collision.

Accordingly under Motorsport UK Regulation **G5.3.3**, I order that you:

	Be disqualified from practice and your practice times are disallowed* (C2.1.1.d)	[4 points]
	Be disqualified from the results of the race (C2.1.1.d)	[4 points]
	Be disqualified from the results of the meeting (C2.1.1.d)	[6 points]
	Be referred to the Stewards of the Meeting for consideration of further penalties	
	Be reported to Motorsport UK as a potential breach of the Respect Code
