Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

Q12.21.4 – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Contact between Car 32 and Car 18 at the Melbourne Hairpin on Lap 4. Both cars continued. Car 32 made nose into side contact with Car 18.

Both drivers interviewed with their team managers. Onboard footage reviewed from both cars. Car 32 is considered to have caused a collision.

Accordingly under Motorsport UK Regulation **G5.3.3**, I order that you:

	Be reported to Motorsport UK as a potential breach of the Respect Code
