Following investigations I find that you are guilty of contravening the following Motorsport UK regulation:

**Q12.21.4** – Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car.

Additional Information / Reasons for Decision:

Contact between Car 70 and Car 11 at Surtees Corner. Car 11 made contact with the barrier and stopped. Car 70 continued. Both drivers interviewed with their team managers.  
Onboard footage viewed from both cars.  
Car 70 is considered to have caused a collision.
