Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Car 101 made front to rear contact with car 45 approaching turn 1, causing car 45 to spin. The Clerk of the Course, having summoned and heard from both drivers and all parties having viewed video evidence, determined that the driver of car 101 was wholly responsible for the collision. The driver of car 101 apologised for his mistake.
 Car 101 did not finish the race and therefore the penalty imposed relates to the next race that the driver competes in.
